- Assets at Bank of America:
- Roofing Fund CD: \$12,003.83
- Checking Account: \$7,335.47
- Total Assets: \$19,339.30
- Treasures Analysis
 Compared to 2020, our 2021 overall assets show a 3.4 % reduction of \$374.08. This is
 within expectations.
- As a non-profit corporation, the general rule of thumb is to not have more than two years budget in reserve. Earlier in 2021, our assets exceeded this 2-year target, so to stay within this parameter, the Club sponsored two Red Cross First Aid & CPR courses,

training a total of 18 members at a cost of \$2,300. This brought our assets in line with the two-year target.

- Side note regarding the Red Cross trainings: Besides helping to balance our reserves, training our members in First Aid and CPR will reflect positively in our GGNRA Park Partner annual review.
- In regard to our budget for the 2021-2022 fiscal year: Our projected expenses are expected to closely balance with our estimated income. Conclusion: The club is financially sound and no adjustment to membership dues is needed at this time.
