Steve received COI. SUP needs to be updated to \$3 million aggregate. We currently have \$2 million, so we've been under-insured. Steve is looking into whether this is actually a requirement. If so, it would require a \$1,000 increase in premiums for chapter site insurance. This also affects WOR. Steve will keep the club posted.
